### Artists & Non Profit Clinics

Mix meet and mingle with artists, arts groups and creative collaborations at workshops on diverse topics designed to aid those in need of a free business tune up without means to hire counsel.

### Bankruptcy Clinics

Bankruptcy attorneys from the Bankruptcy Bar Association staff this free pro se clinic on the second Friday of the month at the U.S. Bankruptcy Courthouse from 12-2 p.m. Pro se debtors first watch a 45 minute video followed by a ? & a workshop.

### Business & Tax Tune Ups

In conjunction with the Venture Law Project and Florida Bar Business Law Section, we assist nonprofit groups in need of free business tune ups at various locations and assist start ups and early stage entrepreneurs in need of business and tax advice to avoid common pitfalls in formation.

### Immigration "UAC" Clinics

In conjunction with DCBA Immigration Law Committee, attorneys appear as Friend of Court in Immigration proceedings on behalf of unaccompanied minors. We provide an overview, mentor and materials to guide you through this process.

### Intake

Attorneys enjoy rolling up their sleeves and interviewing prospective Put Something Back and Landlord Tenant clients - Tuesday & Thursday mornings 9 am- noon at 123 NW 1 Avenue.

### Leave a Legacy Housing Clinics

FREE Information Sessions in partnership with Miami-Dade Housing Authority. Staff important educational sessions to help elderly homeowners who want to learn about estate planning and have questions regarding taxes, insurance and reverse mortgages.

### LegalLine

Participate in the only 1(800) call in program held on the first Wednesday night each month. Firms host the clinic. Arrive at 6 pm at DCBA for dinner, a brief overview and plan to stay until about 9 p.m. Field phone calls and make referrals.

### Small Claims Clinics

Bi-monthly clinics co-sponsored by Legal Aid, YLS and LSGMI. For over 20 years, lawyers staff clinics from 5-8 pm where prescreened clients come in person seeking answers to their questions about how to proceed pro se. One on one consults provided.

### Veterans Affairs Medical - Legal Clinics

Come staff the only VA affiliated clinic in Florida held weekly at the Miami VA on Wednesdays from 9am - noon. The clinic is conducted by the VA and several professionals. After each clinic, the VA refers cases to PSB which we accept or refer to private attorneys/law firms to handle.
