FREE BANKRUPTCY CLINICS ARE AVAILABLE! For individuals considering filing for bankruptcy protection without a lawyer (referred to as a "Pro Se" filer), all bankruptcy clinics will be conducted by video conference using Zoom with a computer, smartphone or tablet. Each clinic will feature a 45-minute video providing an overview of certain procedures for filing bankruptcy, followed by a Question & Answer session staffed by one or more volunteer attorneys who are available to give general advice on bankruptcy matters. These attorneys do **NOT** represent you and cannot provide legal advice regarding your particular circumstances. If you have already filed a bankruptcy case and it is still pending, you are solely responsible for responding to any pleadings or motions and for compliance with any order issued by your Bankruptcy Judge. This also applies to any request for information or documentation from your Bankruptcy Trustee. Unless you are represented by a lawyer, you are solely responsible for protecting your own legal rights. This is a **FREE** service and the attorneys are **NOT** attempting to acquire you as clients. You must register for each clinic, in advance. Information provided by you in the registration process is completely confidential and is used solely to evaluate attendance trends.
