On January 21, 2026, Dade Legal Aid presented the **“You Be the Judge for Newbies & Pros” Probate & Guardianship Seminar** in conjunction with the MDB Probate and Guardianship Committee. Under the leadership of Dale Noll, Esq., Chair of the Committee and Partner at Akerman LLP, we brought this dynamic continuing legal education program designed to equip both new and seasoned practitioners with practical tools for navigating probate and guardianship issues. Offering 4.0 CLE including 1.0 Professionalism, the seminar emphasized real-world problem solving, ethical decision-making, and hands-on learning through case-based discussions.



The program's purpose was to strengthen probate and guardianship practice by engaging attorneys in practical decision-making on issues such as elder exploitation, fiduciary duties, blended family disputes, and the rights of alleged incapacitated persons. By placing participants in the role of the judge, the seminar bridged doctrine and practice while reinforcing Dade Legal Aid's commitment to ethical advocacy and access to justice.
